- The lessee must notify East Waste in writing if he/she moves premises.
- East Waste reserves the right to refuse the additional bin collection service if the service is not being used correctly.
- This Lease Agreement is valid until 30 June 2024, and will be renewed annually for a 12 month period thereafter by way of an Annual Renewal (issued at commencement of each Financial Year).
- The City of Prospect <u>Kerbside Waste Management Policy</u> forms part of the Lease Conditions. Copies of the policy are available from <u>prospect.sa.gov.au</u> or from the Customer Service Desk at 128 Prospect Road Prospect SA 5082
- Lodgement of an application for an additional bin service and/or use of the waste service constitutes
  acceptance of the terms and conditions of the service and renders the applicant liable for any fees in
  connection with the service in the first instance.
