#### **Purpose of the Report**

To call for and appoint a Deputy Chair to the East Waste Board, in accordance with the requirements of the *East Waste Charter*.

#### **Background**

Clause 28 of the East Waste Charter requires the East Waste to have a Deputy Chair at all times.

- 28.1 At all times, the Authority must have a Deputy Chair, who must be a Board Member.
- 28.2 The Board appoints the Deputy Chair and may at any time remove from office the Deputy Chair and appoint a replacement Deputy Chair.
- 28.3 The Deputy Chair's functions are:
  - 28.3.1 to assist the Chair; and
  - 28.3.2 to exercise the Chair's functions whenever the Chair is unable to do so.
  - 28.4 A person ceases to be Deputy Chair if they cease to be a Board Member.

Mr Paul Di Ilulio has held the position of Deputy Chair for the past 10+ years and more than capably stepped into the Chair's role on a number of occasions. It is unclear when Mr Di Ilulio was last formally appointed by the East Waste Board. The position receives no remuneration.

The matter was first presented to the February 2024 East Waste Board Meeting and where due to a number of factors the Board resolved:
