### **Purpose and Context**

To present to the Board the revised East Waste Business Operations Centre (Depot) Lease for the existing premises at 1 Temple Court, Ottoway and seek approval for two Directors to affix the Common Seal and execute the agreement as per the requirements of the *Local Government Act* 1999.

#### **Recommendation 1**

Pursuant to Section 90(2) and (3)(d) of the Local Government Act, 1999 the East Waste Board orders that the public, with the exception of the East Waste General Manager, Rob Gregory, East Waste Manager Business Services, David Maywald, East Waste Finance and Strategic Projects Coordinator, Kelly Vandermoer and East Waste Executive Assistant Vanessa Davidson, be excluded from the meeting on the basis that the East Waste Board will receive, discuss and consider:

- (b) information the disclosure of which—
  - (i) could reasonably be expected to confer a commercial advantage on a person with whom the council is conducting, or proposing to conduct, business, or to prejudice the commercial position of East Waste;
  - (ii) would on balance be contrary to the public interest as the outcome of the decision may impact the tender process.

The East Waste Board is satisfied that, the principle that the meeting should be conducted in a place open to the public, has been outweighed by the need to keep the receipt/discussion/consideration of the information confidential.

#### **Recommendation 3**

Under Section 91(7) and (9) of the Local Government Act 1999 the Board orders that the report, attachment, discussion and minutes be kept confidential until the Lease is executed.
